- ____ (Initial Here) 1. I am aware that I must submit this form to the Town of Severance, along with a \$25.00 registration fee, prior to housing any chickens on the property listed above.
- ____ (Initial Here) 2. I am aware that there will be an annual permit free of \$25.00 to register up to 6 chickens.
- ____ (Initial Here) 3. I am aware that I must first receive a license from the Town of Severance prior to housing any chickens on the property listed above.
- ____ (Initial Here) 4. I am aware that if applicable, I must additionally gain approval from my Home Owners Association (HOA).
- ____ (Initial Here) 5. I am aware that chickens may require veterinary care if they are known or suspected to be sick or injured.
- ____ (Initial Here) 6. I am aware of *Town of Severance Municipal Code Section 7-6-210* and have reviewed all requirements therein.
- ____ (Initial Here) 7. I am aware that I am responsible for keeping any and all chicken within the confines of my property at all times.
- ____ (Initial Here) 8. I am aware that I am responsible for any property maintenance violation related to keeping chickens.
- ____ (Initial Here) 9. I am aware that I am required to comply fully with the following provisions and those found with the *Severance Municipal Code Section 7-6-210*:
- a. Only 6 chicken hens may be permitted per residence;
 - b. Chickens will be housed in a coop that may not exceed sixty square feet;
 - c. The coop will provide proper protection from any seasonal conditions;
 - d. The coop will have an attached yard allowing the chickens to roam and gain access to sunlight;
 - e. The yard will provide a minimum of 10 square feet per chicken and be properly enclosed on all four sides and the top with adequate fencing;
 - f. Coops and yards must be located at least 10 feet from any neighboring property line;
 - g. The health of the chickens must be maintained with proper feed and water.
- ____ (Initial Here) 10. I am aware that any uncorrected violation to conditions contained herein may result in the revocation of my license
